

CTA/CONTRIBUTOR AGREEMENT

Dear Contributor, Thank you for agreeing to contribute to Poly(lactic acid): Synthesis, Structures, Properties, Processing, and Applications, 2nd Edition (the "Work").

Please note that publication cannot proceed without a Contributor Agreement signed by (or on behalf of, pursuant to Paragraph 4(a)(ii) below) all co-contributors. If the Contribution is not accepted for publication or is subsequently rejected, this Agreement will be null and void.

AGREEMENT between whose address is (the "Contributor" which expression will where the context admits include joint contributors) and John Wiley and Sons, Inc., 111 River St, Hoboken, NJ 07030, USA (the "Publisher").

The Contributor has agreed to prepare an original and previously unpublished contribution in the English language (the "Contribution") on the subject of for inclusion in the Work, edited by Rafael Auras, Loong-Tak Lim, Susan Selke, and Hideto Tsuji (the individually an "Editor" and collectively the "Editors"), to be published by the Publisher.

The terms are as follows:

- 1. The Contribution will consist of approximately [word count] words and include all figures (approximately [numeral]) and any supplementary materials agreed with the Publisher, and will be prepared in accordance with the Contributor Instructions provided by the Publisher. The Contributor will be responsible for obtaining and paying for all necessary permissions to use any third-party copyright material in the Contribution in the Publisher's standard form. The Contribution and any permissions will be submitted not later than July 15, 2022, unless the Publisher has agreed to extend the time in writing (the "Due Date"). Upon completion of the review of the Contribution, the Contribution will be returned to the Contributor for revision if changes are required and the Contributor will revise the Contribution in accordance with the instructions or advice. Upon completion of the revision of the Contribution by the Contributor, the Contributor will submit the final version of the Contribution to the Publisher within four weeks of receipt of the review. The Contributor authorizes the Publisher and the Editor to make any amendments to the Contribution which the Publisher may deem desirable in the interests of uniformity and style of the Work. The Publisher discourages the provision of printer-ready material by the Contributor. However, where applicable, the Contributor will ensure that any fonts used in material delivered to the Publisher in printer-ready form or otherwise intended to be reproduced in the form delivered whether in print or digitally will be considered part of the Work and will be limited to approved fonts as outlined in the font guidelines provided by the Publisher. The Contributor will deliver a list of all fonts (in PostScript Name format) included in any such materials delivered to the Publisher when submitting such material. All fonts found to be non-compliant will be fixed, at the cost of the Contributor, by a typesetting vendor of Publisher's choosing.
- 2. As full and final consideration for all rights transferred and all services provided by the Contributor under this Agreement the Publisher will provide each Contributor with one complimentary electronic copy of the published Work or, if the article is part of an updating digital Work, with a one-year complimentary access to the online edition of the Work, for personal, non-commercial, use only. For purposes of clarity, electronic copies of the Work are for the Contributor's personal use and may not be uploaded to a publicly accessible website or systematically distributed, whether or not for commercial or non-profit use, whether for a fee or free of charge.
 - The Contributor may purchase, for personal use only, copies of the print edition of the Work at a discount of 40% from the Publisher's then current United States list price ("List Price") and many of the Publisher's other print publications, except journals and major reference works, at a discount of 25% from the List Price. To receive the discount, the Contributor must register on the Resources for Authors site at www.wiley.com/go/authordiscount. After completion, the Contributor will receive an email containing a unique discount code which can be used on www.wiley.com.
- 3. The Contributor hereby assigns to the Publisher for the full period of copyright and all extensions and renewals (where relevant by way of present assignment of future copyright) the entire copyright and all other rights of whatever nature in and to the Contribution throughout the world including, but not limited to, the right to copy, store and publish the Contribution as part of the Work, or in derivative works based on the Work, or in compilations with other works, or as a condensed version and to issue, rent, sell, transmit and distribute copies of such Contribution to the public in all languages and in all media of expression now known or later developed, and to sub-license or permit others to do so.

- 4. (a) The Contributor represents and warrants to the Publisher: (i) except as disclosed otherwise to the Publisher the Contribution has not been previously published; (ii) the Contribution is the Contributor's original work, all individuals identified as Contributors actually contributed to the Contribution, and all individuals who contributed are identified; (iii) if the Contribution was prepared jointly, the Corresponding Contributor has informed the co-Contributors of the terms of this Agreement and has obtained their signed written permission to execute this Agreement on their behalf as their agent; (iv) the Contribution contains nothing which is libelous, in breach of any obligation of confidentiality or official secrets acts or anything which would constitute a malicious falsehood or is otherwise unlawful; and (v) publication and use of the Contribution will not infringe the copyright, trademark, trade secret, right of privacy or publicity, or any other rights of any third party.
- 4. (b) Where there is more than one Contributor to a Contribution each such Contributor's obligations, warranties and undertakings under this Agreement will be joint and several. In the event of any disagreement between the Contributors which prevents or delays submission of the Contribution by the Due Date or otherwise interferes with the publication of the Work, the Publisher may, in its sole discretion, determine how the disagreement will be resolved and its determination will be final.
- 4. (c) The Contributor[s] will [jointly and severally] hold the Publisher and its distributors and licensees harmless against all liability, including expenses and reasonable counsel fees, from any claim which if sustained would constitute a breach of the foregoing warranties. Each party will give prompt notice to the other if any claim is made and the Contributor[s] will cooperate with the Publisher, who will direct the defense thereof. Pending any settlement, final resolution or clear abandonment of a claim, the Publisher may engage counsel of its choice and may withhold in a reasonable amount sums due the Contributor[s] under this or any other agreement between the parties.
- 5. (a) The Contributor may send or transmit individual copies of the Contribution in any format to colleagues provided no fee is charged and further provided that there is no systematic distribution of the Contribution, for example: posting on a listserve, or automated delivery system. The Contributor has the right to include the Contribution in teaching or training duties at the Contributor's institution/place of employment including in course packs, e-reserves, presentation at professional conferences, in-house training, or distance learning. The Contribution may not be used in seminars outside of normal teaching obligations (for example in commercial seminars), without express written permission from the Publisher. Electronic posting of the final published version of the Contribution in connection with teaching/training at the Contributor's institution/place of employment on an intranet is permitted after publication of the Work, subject to the implementation of reasonable internal access control mechanisms, such as user name and password. The Contributor may make oral presentations based on the Contribution and may re-use all or part of the final Contribution in any other publication authored or edited by the Contributor (excluding journal articles) where such re-used material constitutes less than half of the total material in such publication. In such case, any modifications should be accurately noted. The Contributor may re-use figures, tables, data sets, and artwork from the Contribution, provided the following conditions are met: (i) full and accurate credit must be given to the Contribution; (ii) modifications to the figures, tables and data must be noted; (iii) the reuse may not be made for direct commercial purposes; and (iv) nothing herein will permit publication in other works or in violation of publishing ethics.
- 5. (b) Posting the final published version of the Contribution on the open Internet is not permitted without the express written permission of the Publisher. In addition, any request for commercial reuse of the Contribution must be made in accordance with the Publisher's requirements located at http://www.wiley.com/go/permissions.
- 5. (c) Contributors are allowed to self-archive up to one chapter/article in the version as submitted, provided they are the author or co-author of such chapter, on their personal website, company/departmental and/or institutional or funding body repository or archive, and/or non-commercial subject-based repositories such as PubMed Central or in a Scholarly Collaboration Network (SCN) which has signed up to the STM article sharing principles (http://www.stm-assoc.org/stm-consultations/scn-consultation-2015/), subject to an embargo period of 24 months following publication. The Contributor may not update the archived version or replace it with the published Contribution. Any linking, collection or aggregation of chapters from the same volume is strictly prohibited. In all cases, this is provided that the author(s)/contributor(s) acknowledge that the version posted is the submitted version accepted for publication and includes a full CITE to the final published form, plus link to the homepage of the work on Wiley Online Library.
- 6. If the Publisher fails to publish the Work for any reason, all rights transferred or granted to the Publisher under this assignment will automatically and immediately revert to the Contributor absolutely. If the Contributor fails to deliver the Contribution to the Publisher by the Due Date in a form acceptable to the Publisher the Publisher may terminate this Agreement by notice in writing. The Publisher will have the final decision as to the inclusion or omission of the Contribution in or from the first and any subsequent editions of the Work. The Publisher may request the Contributor to update the Contribution but will be at liberty to engage another suitably qualified person to update the Contribution, provided that the Contributor will be credited as the original author of the Contribution.
- 7. To the extent permitted by law, the Contributor hereby waives the benefits of any and all moral rights and/or rights in the nature of moral rights (other than the right to be identified as the author of the Contribution) which may subsist or may be granted to the Contributor or which may be introduced during the term of this Agreement in respect of the Contribution created by the Contributor pursuant to this Agreement, and the Contributor agrees not to institute, support, maintain or authorize any claim against the Publisher or any licensee of the Publisher that any use made of the Contribution or any changes made to the Contribution in any way constitutes an infringement of any such moral rights.
- 8. The Contributor (and where there is more than one, each Contributor) acknowledges that, during the term of this Agreement and thereafter (for as long as necessary), the Publisher and its partners, licensees and subcontractors may process the Contributor's personal data, including storing or transferring data outside of the country of the Contributor's residence, in order to process transactions related to this Agreement and to communicate with the Contributor and that the Publisher has a legitimate interest in processing the Contributor's personal data (and, where applicable, confirms that the Contributor has obtained the permission from all other contributors to process their personal data). The

Publisher will comply with all applicable laws, statutes and regulations relating to data protection and privacy and will process such personal data in accordance with the Publisher's Privacy Policy located at: http://www.wiley.com/go/privacy.

- 9. Neither party's delay or failure to perform any provision of this Agreement, as a result of ongoing circumstances beyond its control (including, without limitation, acts of God, war, strikes, floods, earthquake, fire, terrorism, epidemic, infectious diseases, governmental restrictions, embargoes, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) will be deemed to be, or to give rise to, a breach of this Agreement. In such circumstances the affected party will be entitled to a reasonable extension of the time to perform such obligations. Either party may terminate this Agreement in the event the force majeure event continues for a period of longer than 180 days. In the event of a termination due to force majeure, the Publisher will revert to the Contributor all rights herein granted, and neither party will have any further obligation or liability hereunder.
- 10. The laws of the country set forth as follows will apply according to your country of residence (as of the date of signing this Agreement), without regard to conflicts of law rules. The corresponding jurisdiction will be the forum for adjudication of all disputes arising in connection with this Agreement:
